GUIDE TO BSGAC MEMBERSHIP TRANSFERS

- 1. Owners of homes with an Active BSGAC membership may transfer the membership to a new owner or to a new address. This can be a benefit to purchasers.
 - a. Owners and/or potential buyers should verify with the BSGAC office the membership status and the amount of Initiation Fee credit that would be transferred.
 - b. We encourage owners to disclose this when listing and include it in the listing. However, BSGAC is not responsible for misinformation in any listing.
 - c. A credit for the amount the previous owner paid for the Initiation fee and the remaining months of the paid membership of any type will be transferred to the new owner.
 - d. The value of a BSGAC membership can vary from \$400+ to well over \$1,000.
- 2. Before closing, the owner should sign the BSGAC <u>Transfer of Membership</u> form.
 - a. This form is available on the web page under downloads or on the membership page. The office will also fax or email a copy upon request.
 - b. This form is also used to Transfer to a new address.
 - c. This form is also used to Resign a membership which is required when members leave.
- 3. The new owner receiving the transfer must fill out a current BSGAC Membership Application (2 pages) and submit it with the balance owed on the Initiation fee + tax. Membership privileges will be transferred and they will not pay any membership fees until renewal time. They must renew the membership by October 15th.
- 4. **TRANSFER VALUE** is the combination of the Initiation Fee Credit plus the membership fees for the remainder of the membership year for the type of membership the unit has.
- 5. Membership Fees are non-refundable and Memberships may not be sold.
- 6. **Understanding the Initiation fee credit given at time of transfer**. (6% sales tax on all payments)
 - a. The current Initiation fee is \$800.
 - b. When BSGAC opened, the original members were offered a half price Initiation fee of \$400 for the month of April 2008.
 - c. In the fall of 2011 and for the Open House held in 2012 the Initiation fee was on a special offer of \$500. No promotions with a reduced Initiation fee are planned.
 - d. There are now many members who paid the full \$800 Initiation fee.
 - e. The new owner will be credited the amount the previous owner paid in Initiation fee: \$400, \$500 or \$800 and they must pay the difference (if applicable) to make up \$800.
 - i. Credit of \$800 New owner pays \$000 NO payment
 - ii. Credit of \$500 New owner pays \$300+tax
 - iii. Credit of \$400 New owner pays \$400+tax
- 7. Understanding the value of the Membership transferred.
 - a. The <u>membership year runs November 1st to October 31st</u> with an annual renewal period from September 1st to October 15th. Seasonal Golf Memberships can be either November through April or May through October.
 - b. Individual buyers actual value received will be based on: the amount of Initiation credit, the type of membership and the number of months left in the membership.
 - c. **Golf Membership with or without a Trail pass may also be transferred** just like the Activity Membership and has far higher values. See the club brochure or our web site for current rates for all types of golf memberships available.
